More than 25 different sports are being contested during June and July in the 2010 Aloha State Games — Hawaii's Olympics for the common person. The 2010 Aloha State Games Wrestling tournament is open to all wrestling enthusiasts. **Dates:** Greco, Friday, June 11; Freestyle, Saturday, June 12; **Venue:** King Intermediate School Gym, Kaneohe, HI.

ALOHA STATE GAMES ENTRY FEE – The entry fee of \$20 per person is designed to cover costs of conducting the meet, including awards and insurance. Children under 10 as of 4/5/10 may enter for \$15. Early registration by mail is encouraged, but there will be registration at the door.

T-SHIRTS – All persons registering before the **June 8 deadline** will receive a T-shirt. Every effort will be made to supply T-shirts in the size noted on the entry forms; if this size is NOT available, then the next available size will be substituted. **Participants registering after June 8 WILL NOT** receive a T-shirt unless they pay the late penalty (\$10 per person). All T-shirts will be delivered to the tournament venue.

Rules: USA Wrestling/FILA Rules **Bout Times:** Three 2-minute periods; must win 2 of 3. **Requirements:** Must be current member of USA Wrestling (on-site memberships available for \$35). **Register Fee:** \$20/person (\$15 for children under 10 as of 4/5/10). May enter both Greco and Freestyle for same fee.

Weight Classes & Format:

1. Wrestlers will be grouped by age and closest weight within 10-pounds.
2. When only 2 people are in a weight/age grouping, best 2 out of 3.
3. When 3 to 5 people are in a weight/age grouping, round robin.
4. When 6 or more people are in a weight/age grouping, double-elimination round robin.
5. Winners determined in round robin formats by advancement points (winner and loser) as follows:
 - a. 5-0 -- win by pin
 - b. 4-0 -- win by technical fall and no points scored by the losing wrestler
 - c. 4-1 -- win by technical fall and at least one point scored by losing wrestler
 - d. 3-0 -- win by decision and no points scored by losing wrestler
 - e. 3-1 -- win by decision and at least one point scored by losing wrestler

Age Groups: Using age as of 4/5/10): 5-6, 7-8, 9-10, 11-12, 13, 14 & 15;16, 17 & 18
(19 if recent high school graduate), 19-over.
